# ACCJ 2014 Person of the Year Award Presented to Yokohama Mayor Fumiko Hayashi

**January 30, 2015** – The American Chamber of Commerce in Japan (ACCJ) announced today that the 2014 Person of the Year Award recipient is Fumiko Hayashi, Mayor of the City of Yokohama.

The ACCJ 2014 Person of the Year Award is being awarded to Mayor Hayashi in recognition of her continuous commitment and dedication to further advancing the strong commercial ties and collaboration between the U.S. and Japan. Additionally, as mayor of one of the most prominent cities in Japan, she has demonstrated strong leadership on such causes as the advancement of women in the workplace, the establishment of an environment welcoming to foreign direct investment (FDI) and the fostering of innovation as a means to overcoming economic and business challenges.

"I am truly honored to receive this prestigious award. Yokohama is an international port city that has developed and flourished through foreign trade and business, including through particularly strong commercial ties with the United States. I have been and remain committed to working hard to promote the advancement of women in society as well as to enhancing opportunities for foreign direct investment and international collaboration in the hope of establishing a more vibrant local economy. I am truly honored that this award recognizes my involvement in trying to improve conditions for foreign businesses. I will continue working to forge strong bonds of "trust and understanding" with a variety of stakeholders including foremostly the great citizens of Yokohama as we endeavor further growth in our city going forward," said Hayashi.

ACCJ President Jay Ponazecki followed by saying "Mayor Hayashi is a remarkable and highly accomplished individual. She is a shining example of an astute leader in both the private and public sectors.



Her ongoing work to enhance the business and living environment in Yokohama for foreign companies and individuals has contributed immensely to strengthening the U.S.-Japan commercial relationship. The ACCJ recognizes these invaluable contributions to the business community at large, and we are honored to present the ACCJ 2014 Person of the Year Award to Mayor Hayashi in the hope of encouraging more people to follow in her footsteps to promote and champion the benefits of expanding the economy through open innovation and collaboration. Further, her tireless dedication to improving conditions for families and particularly working women inspires me and so many at the ACCJ and in the broader business community," Ponazecki added.

The ACCJ Journal's February 2015 issue is scheduled to cover the ACCJ 2014 Person of the Year Award and an interview with Mayor Hayashi. An award ceremony is also anticipated to take place later in the year.
