Laurence W. Bates Elected as 53rd President of the American Chamber of Commerce in Japan

December 4, 2012— Laurence W. Bates was elected by the members of the American Chamber of Commerce in Japan (ACCJ) to serve as the Chamber's 53rd President. Bates begins his tenure on January 1, 2013.

"I am truly honored to be elected President of the ACCJ. The importance of Japan for our member companies, both here in the Japanese market and as a partner for growth in the wider Asia-Pacific region, and even globally, has never been greater. As one of the largest foreign business organizations in Japan, the ACCJ is committed, through thought leadership, not only to furthering the development of commerce between the United States and Japan and promoting the interests of U.S. companies in Japan--but also to improving the international business environment in Japan generally," said Bates.

"As President, I will focus on growth – personal leadership growth of our members through information sharing, networking and advocacy; growth of the ACCJ itself, to further energize our members; and growth of Japanese market opportunities for U.S. companies, through thoughtful advocacy and engagement in the wider region," Bates continued.

Bates currently serves as General Counsel for Japan at GE Global Growth and Operations, with legal, compliance and regulatory oversight for GE's significant portfolio of businesses in Japan. Born in New London, Connecticut, in February 1958, Bates graduated from Yale University (summa cum laude) in 1980, with a Bachelor of Arts in Chinese Studies and Economics, and from Harvard Law School (cum laude) with a Juris Doctor in 1986. Fluent in Mandarin Chinese and Japanese, Bates is admitted to practice law in New York, and prior to joining GE in Japan in 1992, practiced law with major international law firms in New York, Beijing and Tokyo. He was elected a member of the Board of Governors of the American Chamber of Commerce in China in 1989. He also served as a Fulbright Senior Professional Research Scholar at Tokyo University in 1990, where he cotaught (in Japanese) a course on comparative international investment law. Prior



to his current role at GE, Bates served as General Counsel for GE Medical Systems-Asia, from 1992 to 1998, based in Tokyo and Hong Kong, and for GE Capital Japan, from 1998 to 2002, based in Tokyo.
