# 2017 ACCJ Person of the Year Award Presented to Atsushi Saito for Leadership of Japan Exchange Group

**March 20, 2018** – The American Chamber of Commerce in Japan (ACCJ) announced today that it has selected Mr. Atsushi Saito, former CEO and President of the Japan Exchange Group as its 2017 Person of the Year Award recipient.

The 2017 ACCJ Person of the Year Award is being presented to Mr. Saito for his strategic leadership during his tenure as CEO and President of the Japan Exchange Group. Following the 2013 merger of the Tokyo Stock Exchange with the Osaka Stock Exchange, Mr. Saito oversaw the creation of the Japan Exchange Group, which has been instrumental in rebuilding Japan into one of the world's most attractive markets. In addition, Mr. Saito's enormous contributions to corporate governance have made Japanese companies today not only more accountable, but better equipped to face modern business challenges.

"Atsushi Saito's understanding of market demands and the need to be accountable to multiple stakeholders has brought trust back into the Japanese market. By successfully activating an entire industry to pursue meaningful reform, Mr. Saito has fundamentally shifted the way business is done in Japan for the better. The ACCJ is grateful for Mr. Saito's tireless efforts, both past and present, which support a more vibrant business climate and contribute to unlocking Japan's growth potential," stated 2017 ACCJ President and 2018 ACCJ Chairman Christopher J. LaFleur.

Following his tenure as CEO and President of the Japan Exchange Group on August 1, 2015, Mr. Saito was appointed Senior Fellow to the KKR Global Institute, KKR Japan.
