

ACCJ Event Registration Consent Document

PLEASE READ CAREFULLY. THE ACCJ HAS IMPLEMENTED POLICIES FOR HYBRID AND IN-PERSON EVENTS. THE ACCJ ASKS MEMBERS TO CERTIFY THE HEALTH CONDITIONS OF THEMSELVES AND THE GUESTS THEY INVITE TO EVENTS.

I acknowledge and agree to the following, as indicated by my registration for the in-person attendance at this event:

I, on behalf of myself and any guests that I register,

- (i) acknowledge that an inherent risk of exposure to COVID-19 exists in any public place where people are present,
 - (ii) agree that the ACCJ is not responsible for any infection or contagion that an attendee may incur by attending this event in person and the ACCJ will not be responsible for any liability that may arise as a consequence of participation in this event and
 - (iii) by attending this event, agree to voluntarily assume all risks related to exposure to COVID-19 and agree not to hold the ACCJ or the venue where such event is held or any of their respective officers, directors, leaders, employees, or volunteers liable or responsible for any illness or injury that may result directly or indirectly from such attendance.
- I will not attend the ACCJ event in person if I experience or display any of the following symptoms within 7 days prior to the event:
 - Elevated temperature or fever of 37.5 ° C or higher,
 - Cough,
 - Shortness of breath and/or difficulty breathing,
 - Loss of smell and/or taste,
 - Fatigue, muscle aches, chills, shaking, or
 - Persistent headaches
 - I will not attend an ACCJ event in person within the quarantine period, if any, to which I am subject if I return to Japan after international travel;
 - I understand that the full registration fee will be charged after the cancellation deadline has passed, even if I cannot attend the ACCJ event in person for any of the reasons stated in the immediately preceding two bullet points;
 - I will comply with ACCJ and venue safety measures and registration guidelines in order to reduce the risk of spread of COVID-19;
 - I consent that the ACCJ may take my temperature and ask questions as to my health as I enter and throughout the event if deemed necessary by the ACCJ. I will cooperate with those requests and will leave the event if the results are deemed to make me a risk to the event.

By registering to attend this event in person, I confirm that I understand and agree to the terms set out above. If I am registering guests for this event, I confirm that I understand that I am responsible for ensuring that my guests also understand and agree, for the benefit of ACCJ and its members, to the terms set out above.
