Peter Fitzgerald Elected President of the American Chamber of Commerce in Japan for 2020

Since 2015, Peter Fitzgerald has served as the President at Google Japan G.K., where he oversees every aspect of Google Japan's business. Before this, he was Country Sales Director for Google UK/EIRE, the biggest market for Google outside the US. Peter joined Google in 2007.

Peter is a 19+ year veteran of the e-commerce and digital marketing industry, including an 8-year stint at Amazon where he helped launch and develop new categories like Apparel in the US, ran the UK Marketplace business and was Business Development Director for Europe.
