

Membership Options

Corporate Sustaining Membership

Premium value membership designed for multi-national companies offering large scale participation in ACCJ activities, advocacy initiatives, and U.S.-Japan business opportunities; maximum exposure of your brand to the ACCJ network and foreign business community; exclusive access to global CEO peer-to-peer networking and information sharing opportunities, and ease of service benefits.

- Annual dues: ¥1.8m

Corporate Sustaining Membership – *President's Circle Package*

An all-inclusive package for Corporate Sustaining Memberships who additionally desire priority access, a deeper advisory role in the Chamber, extensive corporate exposure, and a simplified cost structure (including cost of sponsorship and free events for the Representative Member).

- Annual cost: ¥7.5m
- Includes annual dues of ¥1.8m + annual package cost of ¥5.7m

Company Membership

Commercial Membership offering exposure to the ACCJ network and foreign business community; participation in ACCJ activities, advocacy initiatives, and U.S.-Japan business opportunities.

- Annual dues: ¥250,000
- Includes Representative Member plus one Additional Member
- Annual dues: ¥75,000 + one-time entrance fee of ¥15,000 for Additional Members beyond the initial 2 members

Company Membership – *Small Company Package*

A lower-cost option for Company Memberships with under 30 employees globally. Ideal for entrepreneurs, start-ups, innovators, and small business owners, offering most benefits of a commercial membership.

- Annual dues: ¥150,000 + one-time entrance fee of ¥15,000
- Includes Representative Member only

Individual Membership

For individuals not associated with an organization, seeking access in a personal capacity to the ACCJ network and foreign business communities; participation in ACCJ activities, advocacy initiatives, peer-to-peer networking and information-sharing opportunities.

- Annual dues: ¥75,000 + one-time entrance fee of ¥15,000

Non-Resident Membership

Low cost option for individuals located overseas or over 100 km away from the ACCJ chapter offices in Tokyo, Osaka, and Nagoya.

- Annual dues: ¥30,000 + one-time entrance fee of ¥15,000
